TINJAUAN UMUM

Dalam Bab.I tinjauan umum dijelaskan antara lain pengertian fenomena perlombaan peratur motor super cepat; pengertian gender; pengertian wisata alam, wisata bahari; warisan budaya tidak berwujud; Raja Masyarakat Batak dan kain Ulos sebagai berikut:

A. Fenomena Perlombaan Perahu Motor Super Cepat Danau Toba

Perkataan “fenomena” adalah hal-hal yang dapat disaksikan dengan pancaindra dan dapat diterangkan dan dinilai secara ilmiah seperti misalnya fenomena alam; gejala misalnya gerhana adalah salah satu fenomena ilmu pengetahuan; sesuatu yang luar biasa atau keajaiban misalnya sementara masyarakat tidak percaya terhadap pemimpin yang berwibawa, tokoh itu merupakan fenomena tersendiri; fakta atau kenyataan misalnya peristiwa itu merupakan fenomena sejarah yang tidak dapat diabaikan.¹ Dalam tulisan ini yang dimaksud dengan “Fenomena” adalah kenyataan perlombaan perahu motor super cepat di Danau Toba yang berlangsung pada tanggal 25-26 Pebruari 2023.

GENERAL REVIEW

In Chapter I, the general overview is explained, among other things, the notion of the phenomenon of super-fast motor racing regulations; the definition of gender; natural tourism; Marine tourism; intangible cultural heritage; King of the Batak Community; Ulos cloth as follows:

A. The Phenomenon of the Lake Toba Super-Fast Motorboat Race



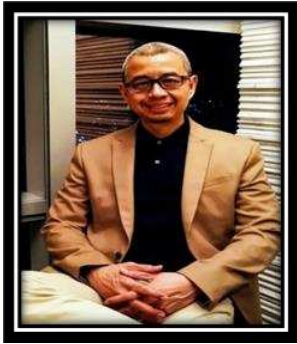
